#### John Hunter Hospital

In response to increased demand for services across the region, NSW Public Works managed the refurbishment of the John Hunter Hospital Paediatric Intensive Care Unit for Hunter New England Local Health District.

The project delivered a standalone eight bed paediatric intensive care unit and four bed intensive care unit, a new reception area, expanded staff room and lift access from the external helipad walkway. An external terrace caters for patient and family use, with additional space provided for future clinical expansion.

Delivered within budget and program, the new facility reflects contemporary models of care in an environment that provides safety, dignity and privacy for children and families.





### Campbells Corner Redevelopment

Muswellbrook Shire Council engaged NSW Public Works to contract manage the renovation and construction of the heritage listed Campbells Corner.

The project involved early works including internal demolition, removal of asbestos contaminated material and the demolition of existing buildings and facilities. The new construction and renovation of the existing space included project surveillance, project assurance and contract management.

Campbells Corner Redevelopment delivered a new modern ground level commercial area along with an ultra-modern facility for the Upper Hunter Conservatorium of Music complete with recording studio, two performance spaces and seven teaching rooms.

#### Cessnock Correctional Centre

NSW Public Works was engaged by Corrective Services NSW to project manage the design, construction and commissioning of a new 250 bed maximum security facility at Cessnock Correctional Complex.

Management of the expansion entailed maintaining normal operation of the existing facilities throughout construction to ensure security requirements continued to meet the stringent conditions.

The new facility offers a safe and secure environment for staff and inmates by providing human and proactive inmate management that focuses on the provision of mentoring programs and vocational training to assist in reducing the incidence of re-offending.





### **GPU** Super Clinic **Raymond Terrace**

This project adds significant and increased health services to the Raymond Terrace community and provides patients with a well integrated mutidisciplinary patient centred care facility.

The provision of the new facility strengthened health infrastructure by replacing outdated, separate and inadequately sized facilities with a design built functional facility.

Complexities of the project included heritage listed jacaranda trees in front of the site, a heritage listed sandstone building across the road from the site, no available information regarding site rehabilitation, construction within a residential business community and management of the contract following liquidation of the original terrace.













#### Fire and Rescue NSW Headquarters

The delivery of the Fire & Rescue NSW (FRNSW) Headquarters provided accommodation facilities to relocate staff from leased premises in 227 Elizabeth Street, Sydney, to a new building at Greenacre and to refurbished premises at Pyrmont Fire Station.

The new headquarters allows FRNSW to coordinate its operations more effectively by bringing much of the operational and administrative functions under one roof for greater efficiency.

The scope enabled FRNSW to embrace a new way of doing business that unifies strategic and transactional centres. The quality fit-out is commensurate with a Government agency head office facility and will allow for easy adaptation to changing needs.





## Warrumbungle National Park Visitor Centre

Warrumbungle National Park is heritage listed due to the geology and biodiversity and is a popular destination for bushwalking, camping and rock climbing.

The Wambelong fire in January 2013 quickly spread under extreme fire conditions and there was significant damage to buildings and park infrastructure including the Warrumbungle National Park Visitor Centre.


The project reconstructed the visitor centre on the same site and provided the National Park with a centre with a unique design that capitalised on the setting and landscape position. A sustainable building was delivered that uses an energy efficient design and materials, and incorporates solar power generation and water capture. The building is low maintenance and fire resistant. The park is heritage listed due to the geology and biodiversity and is a popular destination for bushwalking, camping and rock climbing.

#### State Emergency Services Headquarters

NSW Public Works was engaged by NSW State Emergency Services for the provision of project management services for the base building upgrade and fit-out of the new State Headquarters facility in Wollongong.

The base building upgrade included augmentation and upgrade to lighting and mechanical systems to achieve a 4.5-5 star NABERS building rating. NSW Public Works provided project management support through the feasibility, design and delivery phases of the works to deliver this state of the art facility for SES.

The new State Headquarters supports NSW SES's strategy for development and growth in a purpose built facility.





#### Hunter Valley Hotel Academy

Hunter Valley Hotel Academy is a purpose built facility providing real world training environments for hospitality and tourism students across the Hunter and Central Coast Regions.

NSW Public Works were engaged by TAFE NSW Hunter Institute to undertake contract management and facilitate the design and construction of the new academy, as well as refurbishment of Block L and Block M of Kurri Kurri Campus.

The facility includes reception, restaurant and bar facilities, a commercial kitchen, staff and student change rooms, seminar rooms, administrative offices and a computer room.











### Hunter Sports High School

NSW Public Works were engaged to project manage the design and construction of Hunter Sports High School for the NSW Department of Education.

The role included the initial design brief, concept design and management of the stakeholders consultation process with the local community.

To address the challenge of ensuring that the construction did not impact on the continuity of learning for existing students, the project was delivered through a staged approach which incorporated the construction of three new buildings.





#### Muswellbrook Tertiary **Education Centre**

Muswellbrook Shire Council engaged NSW Public Works to contract manage the design and construction of a new education facility.

The project involved managing procurement, design scope development and design review which included the demolition of an existing site that had heritage and archaeological requirements and the construction of a multistorey building with parking facilities.

The Tertiary Education Centre required ongoing design modifications as the needs of the dynamic end user changed to address their service delivery requirements. NSW Public Works provided a collaborative and proactive involvement with the key stakeholders to manage the impacts of the changes and deliver a facility that meets the needs of the community.

### Ballina Fire Station and Zone Office

NSW Public Works was engaged by Fire & Rescue NSW to project manage the new Ballina Fire Station and Northern Rivers Zone office on a 4,659sqm site at Ballina NSW.

We managed the distinct phases of the project and controlled development of the overall scope.

The project and design provided for the relocation of the existing Ballina Fire Station firefighters and their equipment along with the relocation of the Zone Office staff to the new building.





#### Point Clare Public School

NSW Public Works completed the delivery of Point Clare Public School upgrade for NSW Department of Education. The project received funding through NSW Department of Education's Major Capital Works program and included open plan homebase classrooms with new pedagogy principles.


The Point Clare Public School upgrade provided a new modern multilevel building and increased playground space for students.
